CUTS WASTEFUL PROGRAMS

★ The FY27 NDAA saves taxpayers nearly \$30 billion by cutting needless spending. Savings include:

- ★ \$2.5 billion from retiring obsolete aircraft and ships.
- ★ \$1.8 billion from reductions in unnecessary Pentagon bureaucracy.
- ★ \$1.4 billion in cuts to underperforming and non-defense specific research.
- ★ \$13 billion in cuts to wasteful consulting and service contracts.
- ★ \$12.4 billion in cuts to inefficient defense programs.



FY27 NDAA

The FY27 NDAA roots out waste, fraud and abuse at the Pentagon and saves taxpayers nearly \$30 billion.



ELIMINATES FRAUD & ABUSE

- ★ Prohibits DoW personnel from betting on prediction markets with nonpublic information.
- ★ Requires DoW to implement reforms recommended by the Inspector General (IG) to eliminate improper payments, and fully funds IG audit activities.
- ★ Stands up a Joint Task Force Audit to focus DoW efforts and leverage technology to ensure DoW passes an audit by 2028.
- ★ Requires DoW to implement plans to integrate AI-powered capabilities to improve audit results.
- ★ Strengthens the Pentagon's financial management by creating workforce standards for professional certification and credentialing.
- ★ Requires DoW to fully account for all military equipment transferred or abandoned during withdrawals or force posture changes.
- ★ Requires the Government Accountability Office (GAO) to audit the TRICARE Pharmacy Benefit Program for price and cost discrepancies.

IMPLEMENTS REFORMS TO REDUCE COSTS

- ★ Requires DoW to consider low-cost, mass-produced munitions or other capabilities to reduce costs.
- ★ Makes the Under Secretary of Research and Engineering responsible for certifying the budgets for Research, Development, Test, and Evaluation (RDT&E) across all services.
- ★ Requires the Navy to certify that systems planned for inclusion on the Battleship program are sufficiently mature and technologically sound before awarding a contract.
- ★ Establishes affordability controls on the space-based interceptor program and requires the Secretary to flight-test such interceptors before awarding a procurement contract.
- ★ Eliminates over 40 costly and unnecessary reporting requirements.
- ★ Requires DoW to implement GAO recommendations to reduce costs on the F-35 Joint Strike Fighter.
- ★ Implements cost controls on the Puget Sound Naval Shipyard Dry Dock, the largest military construction project.
- ★ Requires the Navy to assess ways to speed the disposal process for decommissioned nuclear submarines to reduce costs of maintaining submarines that will never return to sea.
- ★ Requires the Navy to certify it has a concept of operations and employment to govern the use of unmanned surface vessels before accepting such vessels.



IMPROVES CONGRESSIONAL OVERSIGHT OF COSTS

- ★ Mandates an annual accounting of military construction overhead costs, requiring disclosure of how supervision, inspection, and overhead funds are collected and spent across every military construction project.
- ★ Mandates annual reporting requirements on the Army's Transformation Initiative to ensure it stays on budget and meets joint warfighting requirements.
- ★ Prohibits the Air Force from spending more than 50 percent of funds for new executive aircraft until they provide Congress with a justification and acquisition strategy.
- ★ Requires the Navy to present surface combat ship maintenance costs as a single line item in the budget request to ensure Congress can better track them.
- ★ Requires an annual sustainment review of each major weapon system that does not meet material readiness objectives, to include an analysis of deficiencies and a corrective action plan.
- ★ Requires regular reporting on the costs of Operation Epic Fury and Operation Southern Spear.
