

**AMENDMENT TO H.R. 3838**  
**OFFERED BY MR. CISNEROS OF CALIFORNIA**

At the appropriate place in title V, insert the following new section:

1 **SEC. 5 \_\_\_\_.** **PROHIBITION ON REMOVAL OF CERTAIN CLUBS**  
2 **AND ORGANIZATIONS FROM SERVICE ACADE-**  
3 **EMIES.**

4 (a) UNITED STATES MILITARY ACADEMY.—Chapter  
5 753 of title 10, United States Code, is amended by adding  
6 at the end the following new section:

7 **“§ 7463. Policy for clubs and organizations**

8 “The Secretary of the Army shall direct the Super-  
9 intendent of the Academy to prescribe a policy with re-  
10 spect to the establishment and operation of clubs and or-  
11 ganizations for cadets. Such policy shall provide that—

12 “(1) faculty and cadets may organize a club or  
13 organization for cadets based on race, ethnicity, reli-  
14 gion, gender, sexual orientation, or other identifying  
15 characteristics provided the club or organization  
16 does not require the use of funds provided by the  
17 Federal Government for operation of the club or or-  
18 ganization; and

1           “(2) ancillary costs of operating the facilities of  
2           the Academy that may be used by such a club or or-  
3           ganization or participation by faculty or staff of the  
4           Academy shall not be considered to use funds pro-  
5           vided by the Federal Government for operation of  
6           the club or organization.”.

7           (b) UNITED STATES NAVAL ACADEMY.—Chapter  
8           853 of title 10, United States Code, is amended by adding  
9           at the end the following new section:

10       **“§ 8482. Policy for clubs and organizations**

11           “The Secretary of the Navy shall direct the Super-  
12           intendent of the Naval Academy to prescribe a policy with  
13           respect to the establishment and operation of clubs and  
14           organizations for midshipmen. Such policy shall provide  
15           that—

16           “(1) faculty and cadets may organize a club or  
17           organization for midshipmen based on race, eth-  
18           nicity, religion, gender, sexual orientation, or other  
19           identifying characteristics provided the club or orga-  
20           nization does not require the use of funds provided  
21           by the Federal Government for operation of the club  
22           or organization; and

23           “(2) ancillary costs of operating the facilities of  
24           the Naval Academy that may be used by such a club  
25           or organization or participation by faculty or staff of

1 the Naval Academy shall not be considered to use  
2 funds provided by the Federal Government for oper-  
3 ation of the club or organization.”.

4 (c) UNITED STATES AIR FORCE ACADEMY.—Chapter  
5 953 of title 10, United States Code, is amended by adding  
6 at the end the following new section:

7 **“§ 9463. Policy for clubs and organizations**

8 “The Secretary of the Air Force shall direct the Su-  
9 perintendent of the Academy to prescribe a policy with re-  
10 spect to the establishment and operation of clubs and or-  
11 ganizations for cadets. Such policy shall provide that—

12 “(1) faculty and cadets may organize a club or  
13 organization for cadets based on race, ethnicity, reli-  
14 gion, gender, sexual orientation, or other identifying  
15 characteristics provided the club or organization  
16 does not require the use of funds provided by the  
17 Federal Government for operation of the club or or-  
18 ganization; and

19 “(2) ancillary costs of operating the facilities of  
20 the Academy that may be used by such a club or or-  
21 ganization or participation by faculty or staff of the  
22 Academy shall not be considered to use funds pro-  
23 vided by the Federal Government for operation of  
24 the club or organization.”.
